

## **Collection Tin and Buckets - Useful Information**

Thank you so much for offering to raise funds using DEBRA's collection tins/buckets. You are not only helping to raise valuable funds for DEBRA, but also raising awareness of our work, thank you.

Please ensure that the tin/bucket is always kept safely – this means that it is ideally secured to a non-movable object using the metal chain provided (tins) and/or it is kept securely when there is nobody around to monitor it. Sadly, collection tins are often a target for thieves, so we need to ensure we all do everything possible to keep the money donated secure.

There are legal and financial requirements in relation to collection tins/buckets and this document helps to ensure that we are fully compliant.

### When you get your collection tin/bucket

It is a legal requirement that all collection boxes/buckets/tins must be issued from DEBRA's Head Office with a number allocated to them.

The collection tin/bucket must be sealed when you receive it and we ask that you complete, sign and return the 'Receipt of collection tin/bucket' form below to ensure that we have all the information required, thank you. Once complete please post to Bracknell head office or email to fundraising@debra.org.uk

If you receive a collection tin/bucket that is not sealed or require more seals please call 01344 771961 or email fundraising@debra.org.uk

### When your collection tin/bucket is full

The collection tin/bucket must be opened and the contents counted in the presence of two people. Both must sign the form to witness the amount collected. This form must then be returned to Head Office either by post or email income.team@debra.org.uk

We ask that you bank the monies yourself at any branch of HSBC or pay into your own account and transfer the monies to the DEBRA account
