

‘Refer a New Member’ prize draw – 1st Oct 2024 – 31st Jan 2025

Terms and conditions

The prize draw

This is an incentive to encourage existing members to promote membership to family and EB contacts, so DEBRA UK can offer support to as many people in the EB community as possible.

Eligibility

Entrants must be:

1. Over 18 at the date a new application is submitted
and
2. A person living with EB or the immediate family member of someone living with EB
and
3. One of the following applies:
 - a. You are an existing DEBRA UK member who has referred someone
or
 - b. You are an eligible new applicant (as per [DEBRA membership policy](#)) who has been referred by an existing DEBRA UK member.

How to enter the prize draw

By providing the referral code NEW24 and the name of the person making the referral on the form, both the applicant and the referrer will get entered into the prize draw.

Prizes

Winners will receive one of the following prizes:

- £200 towards a stay in a DEBRA holiday home
- £100 Amazon gift card
- 5 pairs of bamboo socks

Winner selection

The names of eligible entries will be added into a prize draw.

Referrer names will be entered multiple times, if they are named on multiple applications (1 per household).

The winners will be randomly selected.

Entrants can only win one prize.

Members of the same household can only win one prize.

Winners will be notified by the end of January 2025.

Prize conditions

DEBRA holiday home booking must be made within 12 months of the prize being awarded.

Amazon gift card will be delivered to the winner by post using their address we have on record.

5 pairs of bamboo socks will be of 1 size, specified by the winner. These will be delivered to the winner by post using their address we have on record.

Winners are responsible for ensuring we have their correct email and postal address on their membership record.

Winner notification

The winners will be notified by email by the end of February 2025.

Prize Acceptance

Winners should respond to confirm their email address, full name, postal address and sock size (if relevant). If DEBRA does not receive a response from the prize winner within 1 month, by email, or telephone, the Prize will be given to the next name chosen at random.

DEBRA may request that the winners participate in publicity arising from the incentive. Participation is at the winner's discretion and is not a condition of Prize Acceptance.

DEBRA seeks to run a fair and secure incentive and prevent abuse and cheating. If you enter in a way that is not consistent with these Terms & Conditions, your entry (and any of your associated aliases) will be disqualified. Any Prize awarded may be void and recoverable, and DEBRA reserves the right to bar you from entering future incentives. For this reason, DEBRA reserves the right at any point to:
